An incident is an occurrence, caused by humans, or by natural phenomena, that requires action by emergency service personnel to prevent or minimize loss of life and damage to property and natural resources. It's an event that interrupts normal procedures and has the potential to harm the reputation of a business. Some types of incidents include a hazardous materials release, a fire, a flood, or a terrorist attack.

When an incident occurs, it must be handled properly to alleviate the impact of the event and avert a crisis. This will usually involve action by a number of different agencies working together under the Incident Command System - ICS.

About the series

ICS for Industry is a video-based training package that consists of 3 DVDs plus an accompanying Model Procedures Guide, on CD-Rom. After taking the training provided by the course of instruction suggested, the student should be able to identify the benefits of using ICS, describe the key concepts and principles underlying the National Incident Management System, and describe the basic features of ICS. The student will be able to describe the roles and functions of the Incident Commander, the Command Staff and the four principle sections under ICS. The student will also be able to describe the elements of a crisis management plan and understand the role of the Emergency Operations Center

The three modules are described below:

Module 1 - Incident Management. This program reviews the different levels of inci-

dents and describes the likely impact on public health, safety and the environment. It outlines the concepts and components of the National Incident Management System, stressing the key organizational system provided by ICS. Among the key features examined are span of control, resource management, and communications.

Module 2 - The Response Organization This program examines how incident command is established and transferred, when Unified Command is used, and how an incident command post functions. It covers the responsibilities of the Incident Commander, the structure of the ICS organization, the duties of the Command and the General Staff, and the basic strategies used to deal with an incident.

Module 3 - The EOC & Crisis Management. This module reviews what happens when an incident devolves into a crisis. It stresses the need for a crisis management plan to support on scene emergency response activities, to get outside resources to help control the situation, and to manage the crisis. It examines the role of the Emergency Manager and the Emergency Operations Center in their support of response personnel, and of the Public Information Officer.
