About the series

The Maritime Security ISPS & MTSA Training Series is a collection of 11 videos or DVDs that helps vessel operators, ports and facilities managers address the evolving needs of the maritime industry in the implementation of maritime security management systems. It provides a way to train their maritime employees in the mandatory instruction required by the International Maritime Organization and the U.S. Coast Guard. This comprehensive training package, presented in lecture

format and illustrated with video footage of vessels and port operations, was created by some of the world's leading experts in ship and port security, with input from international law enforcement and maritime agencies.

The course is designed for Port Facility Security Officers, Company Security Officers, Ship Security Officers, crew with security duties, Port State Control Officers, maritime executives, and other appropriate crew members, port personnel, and maritime security organization members. The curriculum adopts and illustrates the approach taken by the ISPS Code that ensuring the security of ships and port facilities is a risk management activity, and an assessment of the risks must be made in each particular case to determine what security measures are appropriate. It is based on the same maritime security training provided at the IMO's World Maritime University in Malmo, Sweden, as well as the U.S. Federal Law Enforcement Training Center.

About maritime training requirements

The ISPS Code, which takes effect in July, 2004, as well as the MTSA require Federal agencies, ports, and vessel owners to take numerous steps to upgrade security and to address anti-terrorism and anti-piracy procedures. Also required is specialized maritime security training for port facility and vessel personnel. Non-compliance with ISPS and MTSA requirements can result in ships being refused issue of the required International Ship Security Certificate, thereby jeopardizing future visits by ships. And without proper training of their personnel, both ships and ports face increased liability in the event of

Titles of the *IMP & MTSA Training Series* include:

1. **Introduction to Maritime Security & Antiterrorism** - A four-part lecture on the history of maritime terrorism, the current threat, and the basics of port and vessel response to this threat. 109 minutes. \$425/VHS \$450/DVD.

7. Threat Identification, Recognition, and Response - Focuses on the characteristics and potential effects of weapons, explosives, & hazardous materials that pose risks to ships and port facilities. 40 minutes. \$295/VHS \$330/DVD.

8. Ship & Port Facility Security Actions - Building on previous courses, develops appropriate procedures to facilitate security actions, including during times of security level change. 50 minutes. \$295/VHS \$330/DVD.

9. Emergency Preparedness, Drills, Exercises and Search Procedures - Explores incident response to a variety of contingencies associated with terrorism and other criminal activities that arise in a maritime setting. Students observe security exercises and drills. 28 min. \$295/VHS \$330/DVD.

10. Security Administrations and Management - Draws upon the ISPS Code and MTSA regulations to demonstrate administrative requirements for documentation and records keeping. 16 min. \$295/VHS \$330/DVD.
